Terms of Agreement and Dove Release Contract

Every Celebration reserves the right to cancel the dove release at any time in the event of inclement weather that is not favorable for a safe return flight of the doves. In the event that Every Celebration determines that weather conditions are not favorable for a safe release of the doves, a full refund (non refundable \$50 not included) will be made by Every Celebration to the client(s).

If the weather forecast predicts possible inclement weather, the client may request that Every Celebration still attend the event. However, if after attending the event, Every Celebration sees the conditions to be unfavorable for a safe return flight, Every Celebration reserves the right to cancel the dove release and retain all fees paid.

Every Celebration reserves the right to cancel a dove release due to dangers to the doves not previously disclosed to Every Celebration. If the danger to the doves is due to the client(s) or their guests, Every Celebration reserves the right to retain all fees paid. If the danger was unforeseen or due to acts of God, Every Celebration will refund all fees paid (non refundable \$50 not included).

If the client(s) cancel the wedding ceremony or delay the dove release for more than 30 minutes, Every Celebration reserves the right to cancel the dove release and retain the fees paid.

Every Celebration believes its doves are safe to handle and fly. However, Every Celebration releases live doves which fly wherever they want when released. Every Celebration is not liable for any damage or injuries caused by the doves. Every Celebration is not liable for damages due to cancellation of a dove release. Every Celebration will not allow doves release in the inner city due too many obstacles such as telephone/electrical wires, traffic lights, and crowded tall buildings. Every Celebration will check the release site to ensure adequate open air space with no obstacles before authorizing the release.

In the unlikely event that Every Celebration loses its flock of doves due to sickness, unforeseen acts of God, or vandalism, Every Celebration will notify the client(s) and refund the fees paid.

The dove release must be done before the release of any balloons, rice, birdseed, confetti, or anything else into the vicinity of the ceremony. This requirement is to ensure that the birds have an opportunity for a clean release, free from any foreign objects obstructing the airway.

The client(s) gives permission to Every Celebration to display any photographs or video footage taken of the dove release on the Every Celebration website and Every Celebration promotional materials. All photographs taken by Every Celebration will belong to Every Celebration.

This contract is an agreement between the client(s) and Every Celebration pertaining to the dove release.

A non-refundable fee of fifty dollars (\$50) is required to secure the date and time of the dove release. The remaining balance is to be paid in full thirty (30) days prior to the release date. Make the check payable to Every Celebration.

Notice: If the weather is not suitable for dove releasing, the release will be cancelled and the remaining balance will be fully refunded. The unsuitable weather conditions are windy days, rainy days, and/or extreme hot days (90 degrees and above). The doves must be released outside.
